Appeal to: His Majesty King Shaikh Hamad bin 'Issa Al-Khalifa regarding the plight of healthcare professionals in Bahrain

From: The members of the Executive Committee of the International Human Rights Network of Academies and Scholarly Societies, listed on the left-hand side of this appeal.

Given the universally recognized moral obligation of health professionals to treat everyone who presents themselves with injury or illness, the Executive Committee of the International Human Rights Network of Academies and Scholarly Societies has resolved, following discussions during its tenth Biennial Meeting, held May 23-26, 2012, to respectfully request that His Majesty, the King of Bahrain, take the following action:

- Release immediately the five healthcare professionals unjustly imprisoned and sentenced to terms ranging from six months to three years. (See attachment for names and sentences.)
- Ensure that the 20 health professionals, most and perhaps all of whom have been tortured to extract confessions and whose sentences range from 5 to 15 years in prison, are pardoned and enabled to immediately return to their important medical work. (The High Criminal Court of Appeal is scheduled to announce its verdict on June 14, 2012.) (See attachment for names and sentences currently under appeal.)
- Urge that all misdemeanor charges against the 28 health professionals currently on trial be dropped.
- Implement immediately all recommendations made by the Bahrain Independent Commission of Inquiry in its report—mandated by you, the King—and issued on November 23, 2011.
- Reinstate and remunerate promptly and fully all health professionals removed from their jobs since peaceful demonstrations began.

We make these requests regarding our Bahraini colleagues with utmost respect and because of our great concern for their health, well being, and obligation to fulfill their professional duties.

Bahraini health professionals unjustly imprisoned:

- 1. Younis Ashouri, 60 years old, administrator at Muharraq Maternity Hospital sentenced to 3 years for sending an oxygen cylinder to the medical tent.
- 2. Hassan Maatouq, 30 years old, emergency specialized staff nurse sentenced to 3 years for attending a public gathering.
- 3. Ahmed Almushatat, 27 years old, pharmacist sentenced to 2 years for attending a public gathering.
- 4. Hasan Alarabi, MD, 24 years old, medical doctor sentenced to 6 months.
- 5. Ahmed Mahdi Saleh, 19 years old, psychiatric nurse recently detained on April 19th and sentenced to 6 months for attending a public gathering.
